# Next Generation Academy's SBE Approved Alternative Assessment

#### **DIBELS 8th Edition**

DIBELS stands for Dynamic Indicators of Basic Early Literacy Skills.

DIBELS is a series of short, quick assessments used to determine if scholars may be struggling with reading and need additional help. Teachers use DIBELS to inform their reading instruction.



### **End of Grade (EOG)**

The EOGs are tests that begin in third grade and measure your scholar's achievement on standards taught in reading and math.

- Math: Calculator Active and Inactive
- Reading
- Approximately 240 minutes with a break every 45 minutes.

## Beginning of Grade (BOG)

The BOG is a Reading Test is linked to the Read to Achieve law and is aligned to the North Carolina Standard Course of Study (NCSCOS)

#### NC Check-Ins 2.0

#### NC Check-ins are for Grades 3-8:

- Formative assessments developed by the North Carolina Department of Public Instruction's Annual Testing Program.
- Check-ins provide instructional guidance to support teacher instructional planning.
- Aligned to North Carolina grade-level content standards.
- Provides an estimate to inform a student's summative assessment experience.
- Three times a year (End of first three quarters)
- Math Check-ins only cover specific NC Grade Level Standards.
- Reading and Math- 90 Minutes (Calculator Active and In-Active.)

## **Test Taking Strategies**

- 1. Read everything on the screen, including charts, graphs, captions, and illustrations.
- 2. Reference the text when answering questions.
- 3. Pay attention to the wording of the questions.
- 4. Use your strategies when reading and solving word problems.
- 5. Use your calculator while taking the calculator active portion of the EOG.
- 6. Think and show your work for all problems. Use your white paper and grid paper to work out the problems.
- 7. Read <u>ALL</u> of the answer choices. Eliminate the ones that you know are not correct.

# SB 387 Excellent Public Schools Act

An act to modify the implementation of the North Carolina Read to Achieve Program to attain statewide reading proficiency by third grade.

The Read to **Achieve Law** General Statute §115C-83.7(a)

RtA law states that the State Board of Education (SBE) "shall require that a student be retained in the third grade if the student fails to demonstrate reading proficiency appropriate for a third-grade student as demonstrated on a Stateapproved standardized test of reading comprehension administered to third-grade students."



## Pathways to Meet the Read to Achieve Guidelines

A third-grade student may be promoted to fourth grade if the student demonstrates reading proficiency through one of the following options:

Score a level 3 or higher on BOG, EOG or RtA

Pass DIBELS 8 with a 725 lexile level

Successfully completes a Grade 3 Student Reading Portfolio


\*Qualify for a good cause exemption.



What happens if my scholar doesn't pass the EOG and doesn't score high in other areas?






### **Reading Camp**

- Provided by Next Generation Academy by invitation to 2<sup>nd</sup>— 3<sup>rd</sup> grade scholars not proficient in reading
- No cost to parents
- Scholars receive a minimum of 72 hours of reading instruction
- Opportunity to take RtA Alternate Assessment (3<sup>rd</sup> grade)
- Enrollment is not mandatory
